Service Hours

- 1. Service by Appointment:** Clients must book an appointment prior to visiting campus. You may call (843)573-0078 to schedule an appointment or you may book an appointment online via <https://www.topofthelinebarbercollege.edu/book-online>. Walk-in clients will be accepted on a limited basis and at the discretion of the supervising instructor.
- 2. Waiting Area/Lobby Removed:** Clients must wait outside in their vehicles until they are called for service.
- 3. Covid-19 Screening Questionnaire:** All clients must complete a health questionnaire prior to being served. Clients will also have their temperatures taken digitally and recorded. Clients with a fever will not be admitted or served.

Terms of Service

1. **Student-Barbers:** All hair care services will be provided by student-barbers training under the direct supervision of licensed instructors. Please note that you may experience longer wait times and that your service may take longer to complete.
2. **Age Limits:** Clients of all ages are welcome; babies/toddlers must be at least one (1) year old. All minor clients under the age of eighteen (18) must obtain their parent's permission prior to being served. Due to health & safety restrictions, children less than 12 years of age must always be accompanied by an adult.
3. **Color Services:** A skin-patch test is required 24 hours prior to color service. The skin-patch test is conducted at no cost. Please call ahead to arrange for a skin-patch test prior to booking a color appointment.
4. **Pricing:** All prices listed are starting prices. Clients will be charged for any product(s) that needs to be used, if necessary, to complete service. An instructor will inform a client of any additional charges and obtain the client's permission before proceeding with the service.
5. **Student Requests:** Clients may request an individual student by name when scheduling an appointment; however, we cannot guarantee that the student requested will be available at the time of your appointment. We will make every attempt to honor a client's request, however the supervising instructor makes all determinations regarding client requests.
6. **Refunds:** No refunds are available for hair care services. Refunds for retail purchases are handled by the business office. Please call (843)573-0078 and ask to speak with the business manager.
